## WAIVER OF LIABILITY FOR ALL CLAIMS AND RELEASE OF LIABILITY

### PLEASE READ CAREFULLY BEFORE SIGNING.

Completed waivers are to be returned either with online registration or prior to attending the Organizer's event:

(the "Event")

By signing below, the Participant (named below), and/or the Participant's parent or legal guardian are agreeing to the following terms:

**Assumption of Risk:** The Participant and/or the Participant's parent or legal guardian are aware and understand that participation in the Event involves many risks, dangers, and hazards, including, but not limited to, the risk of serious injury, illness, death, or property damage. The Participant and/or the Participant's parent or legal guardian acknowledge that the Participant is voluntarily participating in the Event. By signing below, the Participant and/or the Participant's parent or legal guardian are freely accepting and assuming any and all risks, dangers, and hazards associated with the Participant's involvement in the Event and the possibility of injury, illness, death, or property damage which may arise as a result of the Participant's participation in the Event, whether caused by the negligence of the Organizer, or otherwise.

**Release of Liability:** By signing below, the Participant and/or the Participant's parent or legal guardian and the Participant's heirs, executors, insurers, administrators, and next-of-kin hereby expressly waive and release any and all claims for any injury, loss, or damage to person or property which the Participant has, or may in the future have, against the Organizer, its affiliates, and their respective directors, officers, employees, volunteers, sponsors, partners, agents, representatives, shareholders, successors, and assigns (collectively, the **Released Parties**), arising out of, or attributable to, the Participant's participation in the Event, due to any cause whatsoever, including, without limitation, the negligence of the Organizer or any of the Released Parties, breach of contract, or breach of any statutory or other duty of care owing under occupiers liability legislation or otherwise. The Participant and/or the Participant's parent or legal guardian covenants not to make or bring any such claim against the Organizer or any of the Released Parties, and the Participant and/or the Participant's parent or legal guardian forever releases and discharges the Organizer and all other Released Parties from liability under such claims.

**Indemnification:** By signing below, the Participant and/or the Participant's parent or legal guardian acknowledge and agree that the Participant shall defend, indemnify and hold harmless the Organizer and all other Released Parties against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind, including reasonable legal fees, in connection with any third-party claim, suit, action, or proceeding arising out of or resulting from the Participant's participation in the Event.

**Responsibility of Participants:** The Participant and/or the Participant's parent or legal guardian understands and accepts that it is the Participant's responsibility to act within the Participant's personal physical limits, follow safety instructions and all rules associated with the Event, abide by all applicable laws and guidelines of the host facility, and use all equipment properly. The Participant and/or the Participant's parent or legal guardian further certifies that the Participant is physically fit and able to participate in the Event, and that there are no medical or health concerns that would affect the Participant's participation in the Event, including, but not limited to, experiencing known symptoms of illness such as fever, cough, shortness of breath, diarrhea, or nausea. If the Participant experiences any medical or health concerns during the Event, the Participant will immediately cease participation in the Event and inform the Organizer.

**Consent for Minors:** If you are the parent or legal guardian for a Participant under the age of 18, you hereby consent to the Participant's participation in the Event, and you agree to the above terms and conditions on the Participant's behalf.

**BY SIGNING BELOW, YOU ACKNOWLEDGE THAT YOU HAVE READ, UNDERSTOOD, AND VOLUNTARILY AGREE TO BE BOUND BY ALL OF THE TERMS AND CONDITIONS SET OUT ABOVE, AND THAT YOU ARE VOLUNTARILY WAIVING SUBSTANTIAL LEGAL RIGHTS (ON YOUR BEHALF AND/OR ON BEHALF OF THE PARTICIPANT AND THEIR HEIRS, EXECUTORS, INSURERS, ADMINISTRATORS, AND NEXT-OF-KIN), INCLUDING THE RIGHT TO SUE THE ORGANIZER AND ANY OF THE RELEASED PARTIES.**
